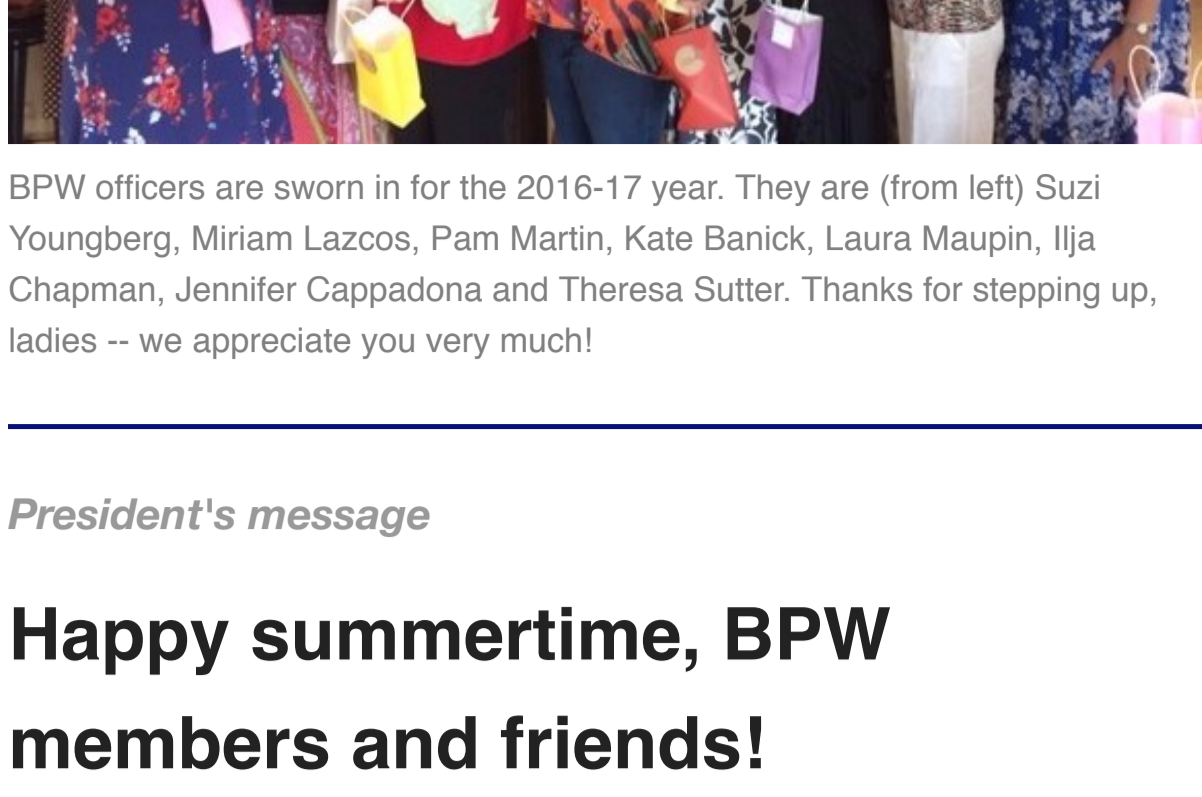

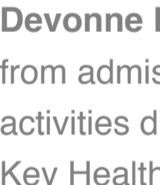

Our Speaker: Cheryl Meads



Cheryl Meads was the whistleblower in a landmark case she brought on behalf of the federal and state governments alleging that pharmaceutical giant GlaxoSmithKline released to the market contaminated and adulterated drug products from its huge plant in Citra, Puerto Rico. In October 2010, following a 6-year investigation by the Department of Justice, GSK paid the government \$750 million to resolve the Meads' lawsuit, including a \$150 million criminal fine and felony guilty plea.

Cheryl is a Manager of Global Quality Assurance for GSK. She has a degree in Chemistry and is an expert in managing large teams ensuring pharmaceutical QA and FDA regulatory compliance. In 2002 she was given responsibility over the Citra plant. She complained to numerous GSK senior execs about conditions at the plant and urged that the plant be closed. She alerted GSK's CEO and General Counsel, and made a full report to the Compliance Department, but no action was taken. She

then reported to the FDA, which carried out the largest seizure of adulterated drug products in FDA history at the plant. In 2005, the plant's output was restricted by the FDA, and by 2008, when it closed, only one drug product was still made there. Meads is a Board member of Taxpayers Against Fraud, a DC-based public interest group that promotes whistleblower laws. She is the founder of a real estate company and is engaged in various philanthropic endeavors, primarily in health care and housing, in the US and abroad. She is also a Councilwoman in Islamorada, seat #2.

Debra London

In 1977, I moved from Pennsylvania (alone at 17 years old) to Miami and attended Miami-Dade Community College downtown campus and then Florida International University (FIU) studying Business Administration.



The operations management professor at FIU (who was also the operations manager at Motorola in Fort Lauderdale) requested resumes from the top five students in class and I was one of those (I had paid my way through school as a bartender and waitress with no parental assistance.)

Luckily I was hired to work at Motorola in the position of purchasing agent for circuit boards and flexible circuits. Looking back now I realize how much confidence they had in me as a 24-year-old woman since you can't build a radio or a pager without the circuit board first!

Motorola also paid for higher education and I was able to obtain my master of business administration degree while employed there. I purchased my first home in Fort Lauderdale at 26 years old. I married my husband and had a son Johnny (now 26) and a daughter Lauren (now 23) who still live in Fort Lauderdale.

My career in procurement continued to working for Broward County government until 2012 when I permanently relocated to Monroe County, where my Round Up Fishing Charters cofounder and I have the business.

I also worked full time for the City of Marathon from 2012-14 on projects such as the Grassy Key Fire Station, the City Hall and the Oceanfront Park.

In 2014, I was hired as a project manager for Monroe County working out of Key Largo -- thank God I did not have to make the 104-mile round trip commute to Marathon anymore!

The projects I work on are primarily roadway and drainage improvements in addition to the U.S. 1 bypass shared use path, the pedestrian and bicycle trail, Marvin Adams Highway (the cut), Big Pine Key, the entrance and exit signs, Pigeon Key ramp and other construction projects.

For fun, I love being on the water -- my favorite way to see the Keys is by catamaran on the weekends!

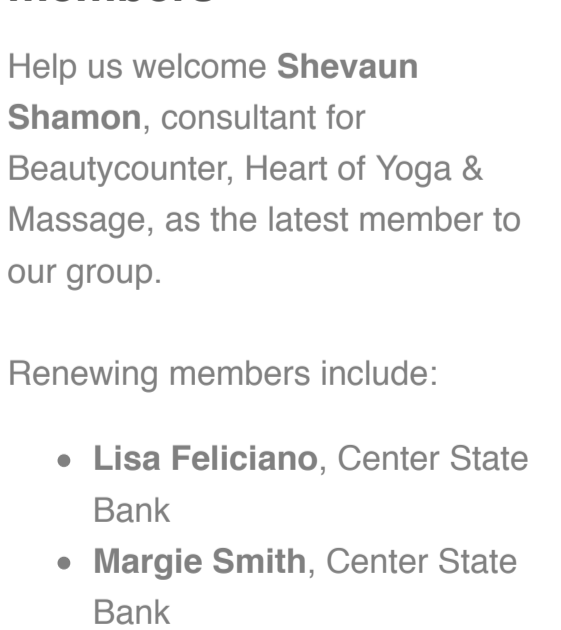
Margie Smith has been appointed as president-elect of the Ocean Reef Chamber of Commerce. What an accomplishment!

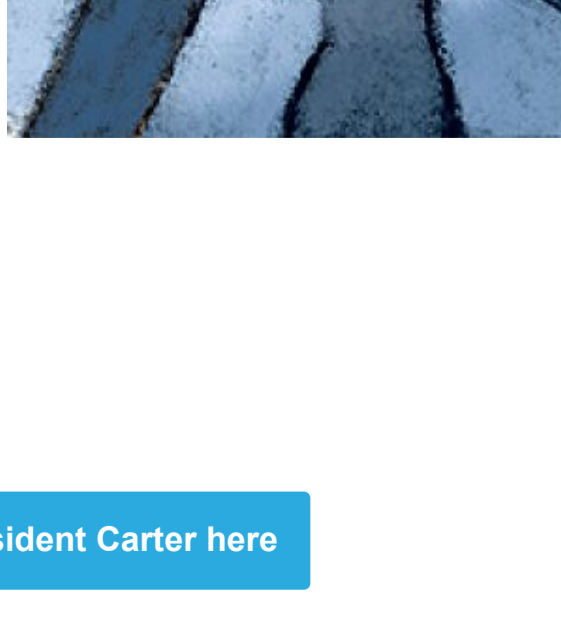

New addition to the fleet

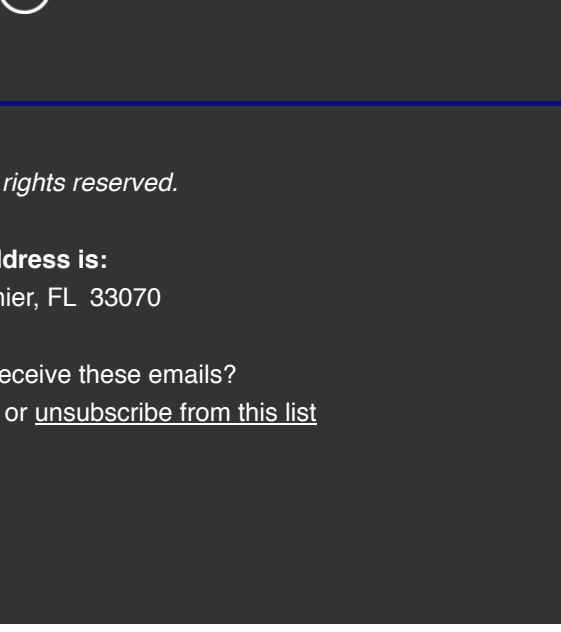

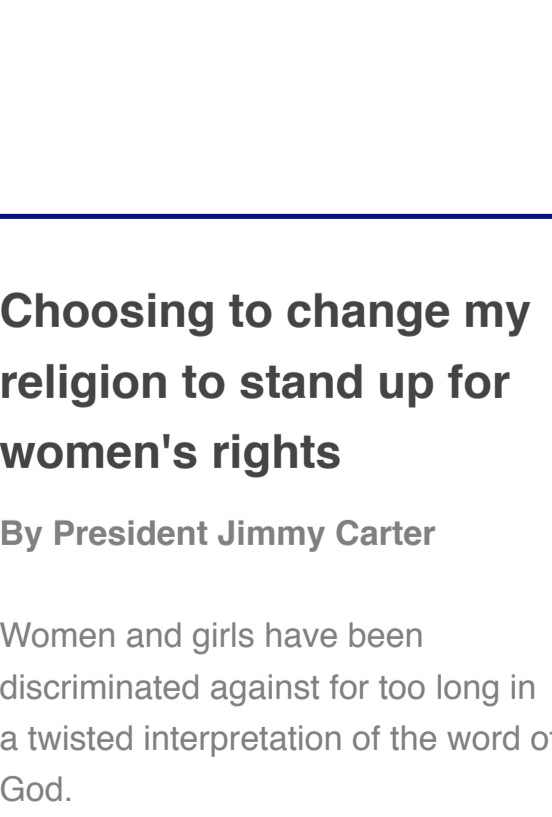

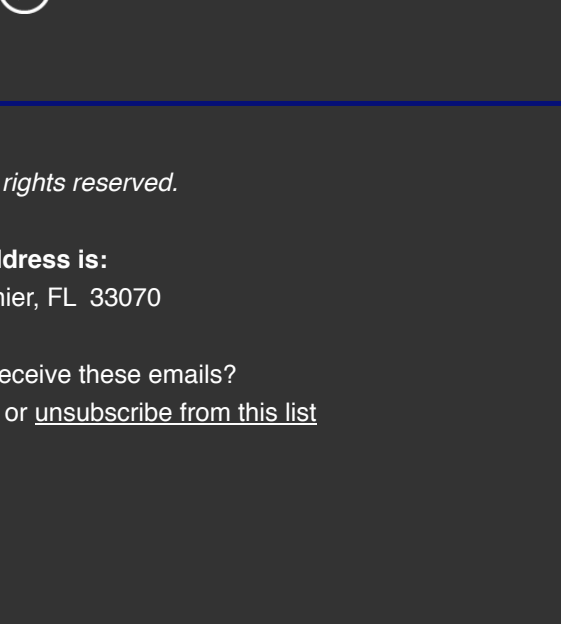
