Florida SBDC at Florida Keys Community College is currently coordinating the Emergency Bridge Loan Program funded by the State of Florida for small businesses.

These are loans intended for operating capital; \$50,000 max, six month term, nointerest. Application deadline is October 31st. We are also assisting clients with SBA Disaster Loan Applications. Those loans max out at 2 million for both damage to property and economic injury. If you need help for your small business, please register with us via the link below. There is never any cost of our one on one counseling. Our program is funded by the SBA, the State of Florida, and Florida Keys Community College.
